Release of Liability Waiver

I, the undersigned, understand that Boys & Girls Club of Camarillo (BGCC) does not own or operate the vehicles that will be used to transport the undersigned to the BGCC, but that BGCC has hired Roadrunner Shuttle Service, a third party bus charter company to provide transportation to BGCC.

I fully understand that traveling by vehicle involves risks and dangers of serious bodily injury and potentially death; these risks and dangers may be caused by my own actions or inactions, the actions and inactions or other drivers or passengers; there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and as between myself and The Boys & Girls Club of Camarillo, I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the transportation program.

I hereby release, and covenant not to sue The Boys & Girls Club of Camarillo, its administrators, directors, officers, partners, volunteers and employees ("Releasees") from any and all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise and I further agree that if, despite this release and waiver of liability, assumption of risk and indemnity agreement, I, or anyone on my behalf, makes a claims against any of the Releasees, I will indemnify save and hold harmless each of the Releasees, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which may incur as a result of such claim.

I understand that this form will be used against me in any proceeding in which I make any claim of any kind against the Releasees, on my own or on behalf of, or as a representative of, the Child.

I represent and warrant that I am the parent, natural guardian and/or legal guardian of the Child, who is a minor, and who is also seeking permission to participate in the Activities at my request and, in such capacity, on my behalf and on the behalf of the minor participant, the Child, I irrevocably agree to the terms and conditions set out above.
